Bidding will be conducted through International Competitive Bidding (ICB) procedures in accordance with Sierra Leone National Public Procurement Act, 2004 and open to all eligible bidders, who can demonstrate the ability and financial capability to supply the required items and also provide the ancillary services.

Interested eligible Bidders may obtain further information from and inspect the bidding documents at the **Procurement Unit**, **National Revenue Authority**, **2**nd **Floor**, **Modesty House at 7 Bathurst Street**, **Freetown from 9.00am to 5:00pm on Mondays to Fridays inclusive except on public holidays.**

A complete set of bidding documents may be purchased by interested bidders upon payment of a non-refundable fee of LE 500,000 (Five Hundred Thousand Leones) for bidders within Sierra Leone and Le1,000,000.00 (One Million Leones) for international bidders (this include cost of mailing the documents). Payment should be by cash into NRA's Account {001-110618-10-00-01} at the Sierra Leone Commercial Bank, Siaka Stevens Street, and pay-in slip must be submitted to the Finance and Procurement Units.
- 6. Bids must be marked on the outer envelope "SUPPLY, DELIVERY, INSTALLATION AND SUPPORT OF A CALL CENTRE SOLUTION" and delivered to the above office on or before 12.00 pm on December 29th, 2014 and must be accompanied by the following documentation:
 - A Bid security of LE 20,000,000 or 4,000 US dollars which must be in the form of a valid Bank Guarantee from a reputable Bank and recognised by the Central Bank of Sierra Leone;
 - A True Copy of a valid Business Registration Certificate
 - Evidence of performance of similar contracts
